Medication Therapy Management (MTM)

Medication Therapy Management (MTM) is defined by the American Pharmacists Association as "a group of services that optimize therapeutic outcomes for individual patients" and "are independent of, but may occur in conjunction with, the provision of a medication product."

MTM is individualized to the needs of the patient and includes a broad range of professional activities and responsibilities within the licensed pharmacist's scope of practice (not an all-inclusive list):

- Perform or obtain necessary assessments of the patient's health status
- Formulate a medication treatment plan
- Identify, resolve, and prevent medication-related problems, including adverse drug events
- Monitor and evaluate the patient's response to therapy, including safety and effectiveness
- Provide education/training to enhance patient understanding and appropriate medication use
- · Coordinate support services to enhance patient adherence with therapeutic regimens
- Communicate findings and recommendations to the patient's other healthcare care providers

State and federal legislation have required payers to incorporate MTM coverage into their pharmacy or health plans' benefits (e.g., 42 CFR § 423.153(d) and N.D.C.C. chapter 26.1-36.11). However, eligibility requirements for MTM services may vary between payers.

ND Medicaid has covered MTM since 2018 for traditional Medicaid members. Blue Cross Blue Shield of ND covers MTM for expansion Medicaid members as of 2023. If you identify a patient who could benefit from MTM, consider asking a pharmacist to engage in providing these services for your patient.

MTM services may be particularly beneficial for patients with:

- Medication adherence-related problems
- Uncontrolled disease states
- High-risk social practices
- Limited health literacy

Drug Specific MTM Opportunities

ProAir RespiClick

ProAir RespiClick works differently than other HFA inhalers. MTM opportunities exist to ensure patients are properly using this medication. Some important counseling points for ProAir RespiClick are listed below:

- A spacer cannot be used with ProAir RespiClick. By breathing in, you activate the inhaler to deliver the medication, so you don't have to coordinate "pressing and inhaling" to receive a dose during an asthma attack.
- ProAir RespiClick does not need to be primed.

An important feature on this website is the NDC Drug Lookup, which allows you to determine if a specific NDC is covered (effective date), reimbursement amount, MAC pricing, copay information, and any limitations (prior authorization or quantity limits).
